

Public opinion survey to assess the changes in citizen's awareness of civil society and their activities

Methodology: quantitative survey of Ukrainian population

Sample size

2,054 residents of Ukraine.

Sample design

The interviews were conducted with the residents of Ukraine aged 18 years old and older. Sample design corresponds to the distribution of adult population of Ukraine by age, sex, oblast and settlement type according to the data of the State Statistics Service of Ukraine as of January 1, 2018 (excluding AR Crimea and NGCA of Donetska and Luhanska oblasts).

Margin of sample error (not including design effect) does not exceed 2.2% for national sample.

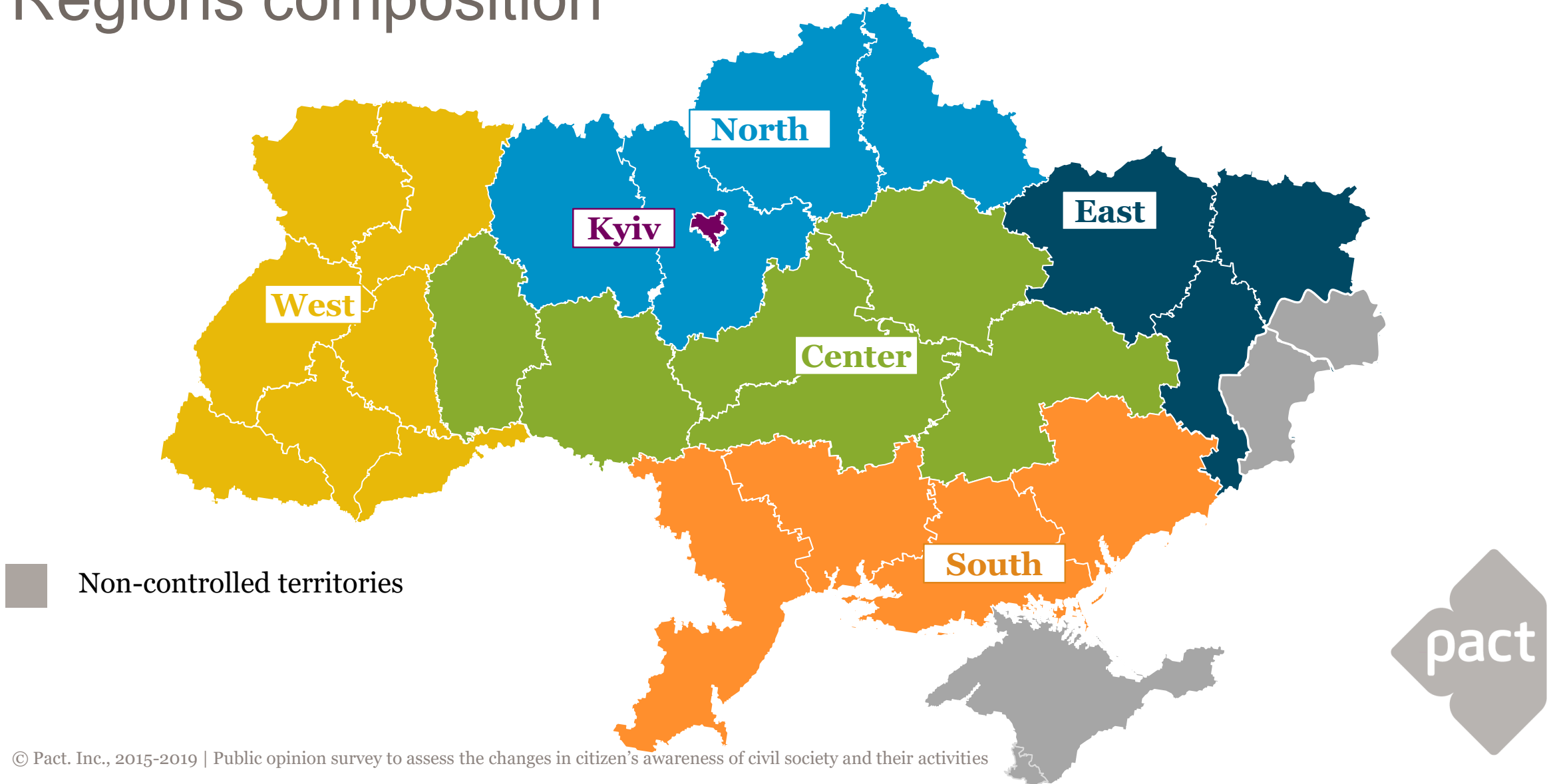
CAPI: face-to-face interviews on tablets at respondent's home

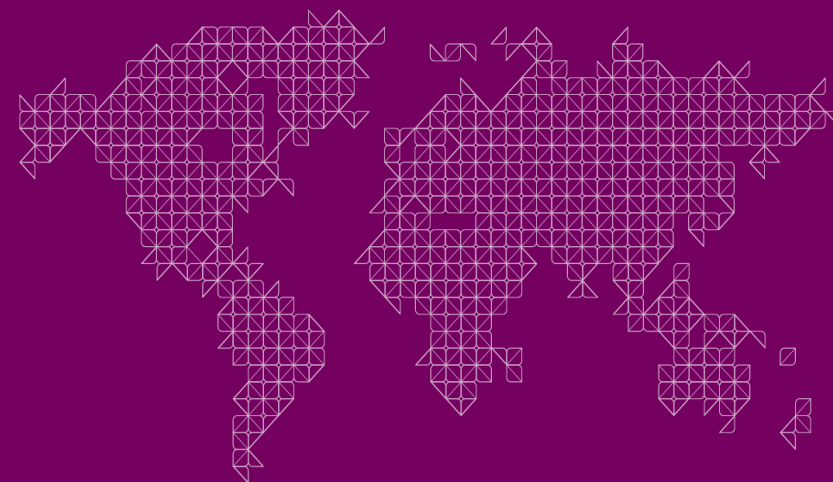


Regions composition

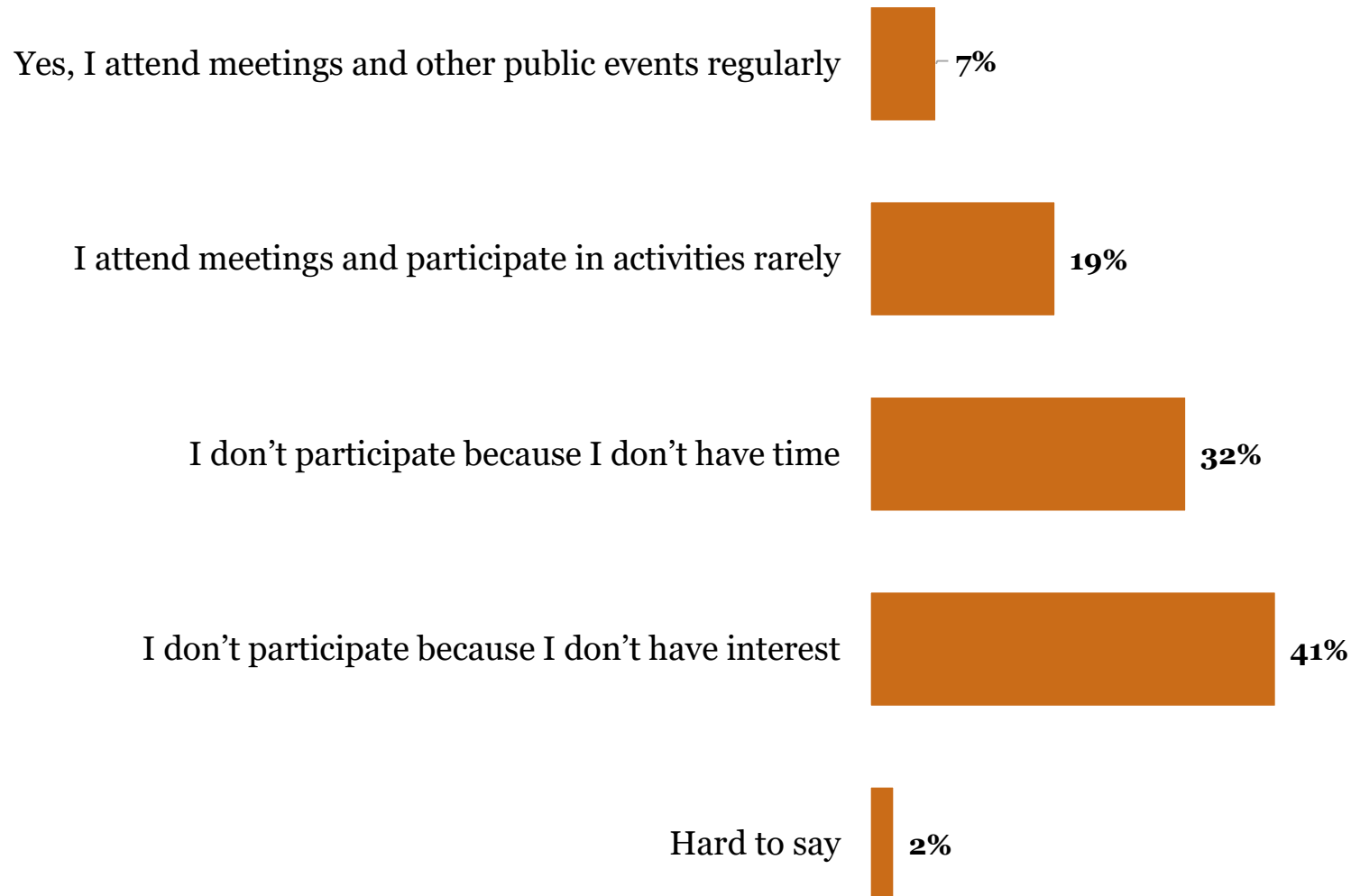




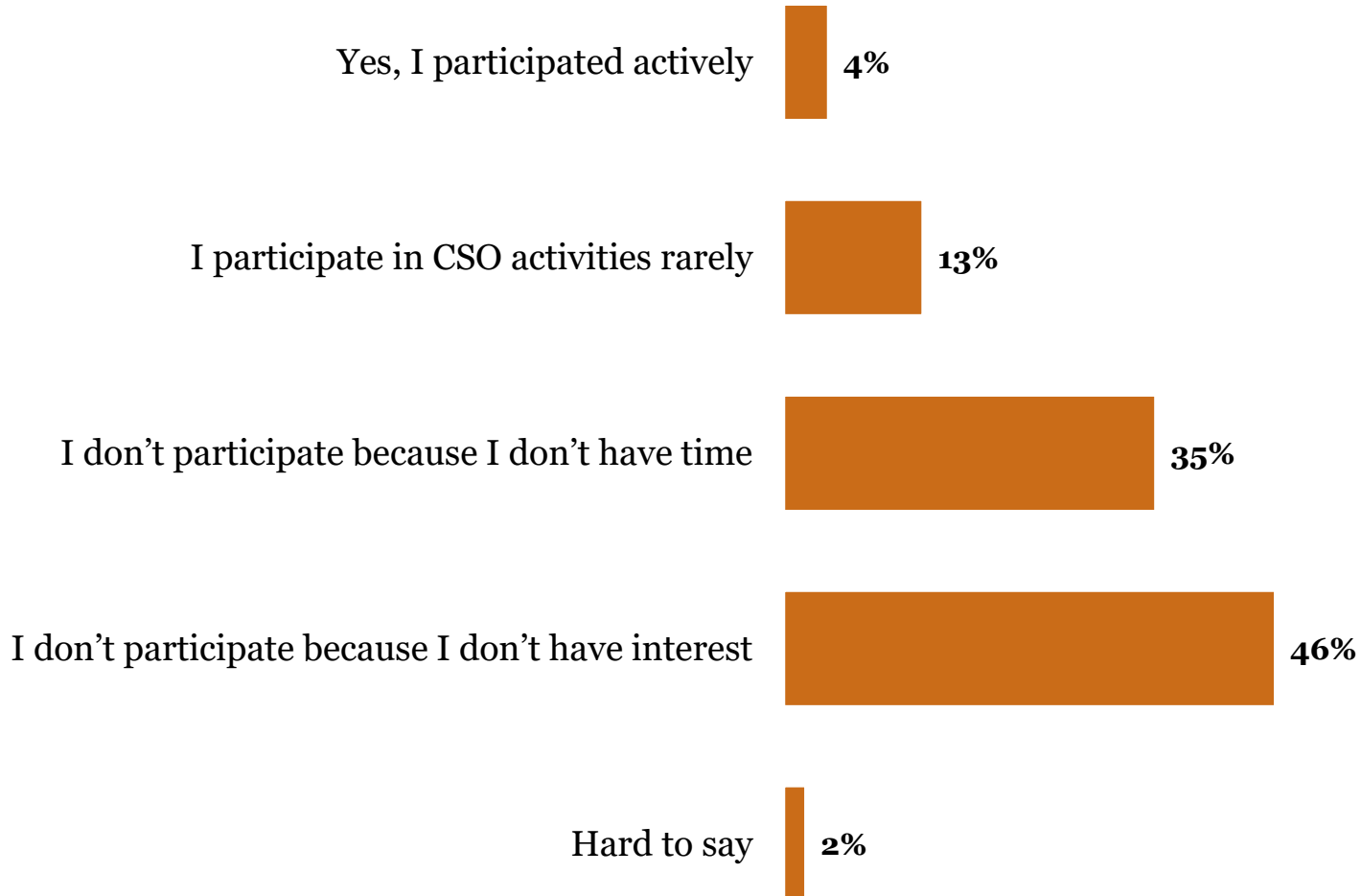

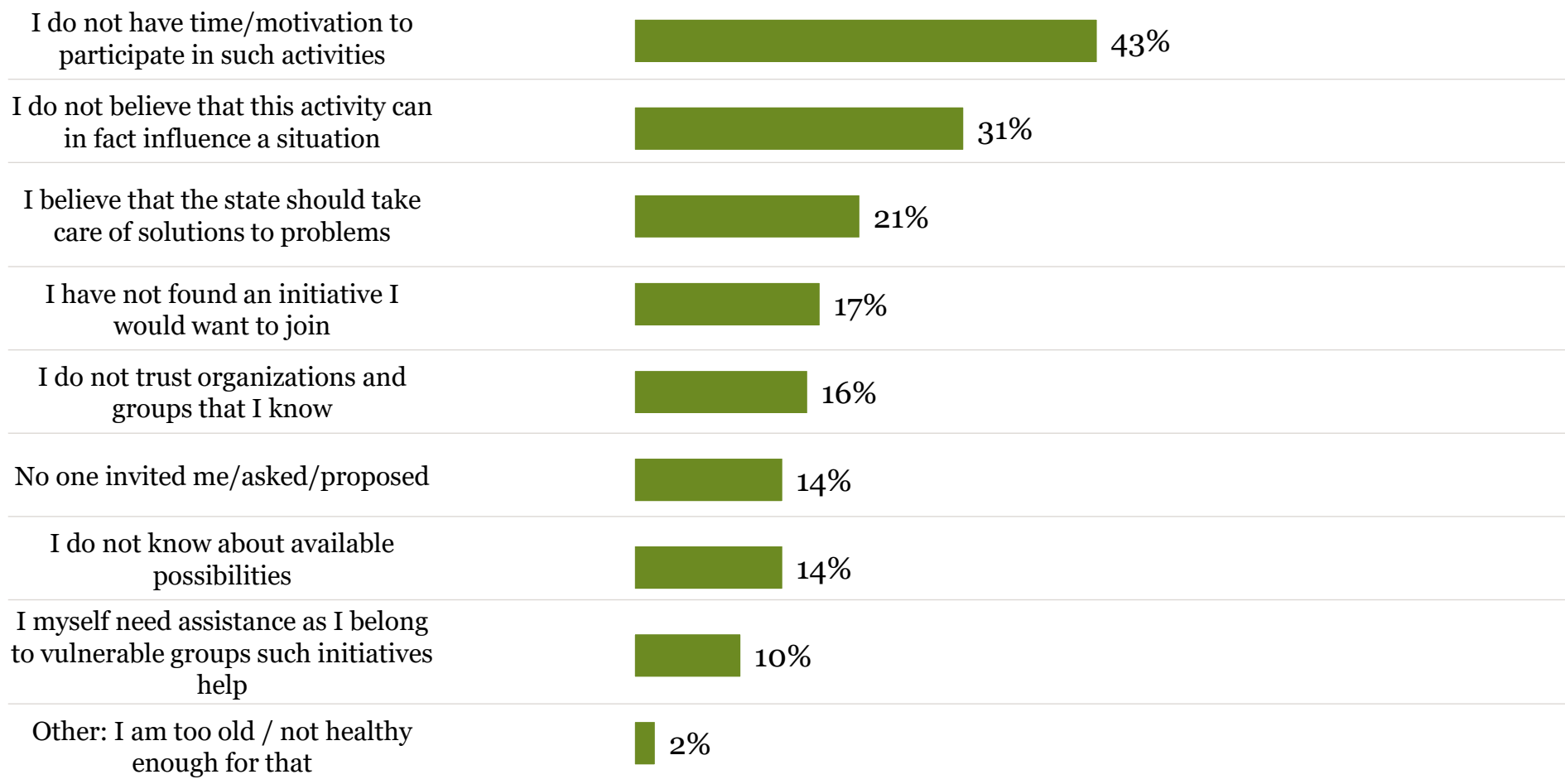

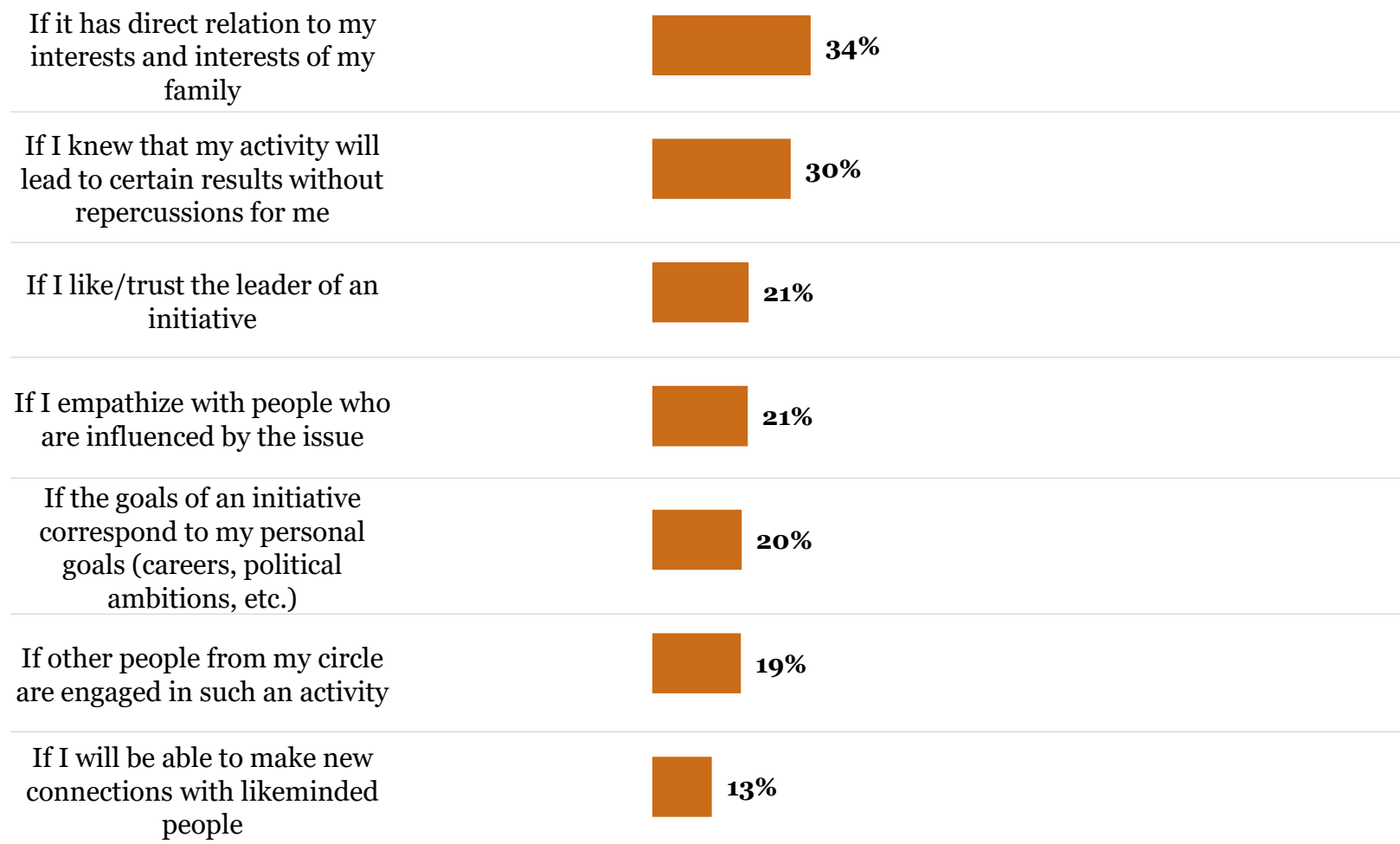
- Overall, positive experience, I achieved the result I wanted from it

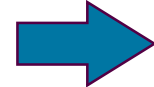
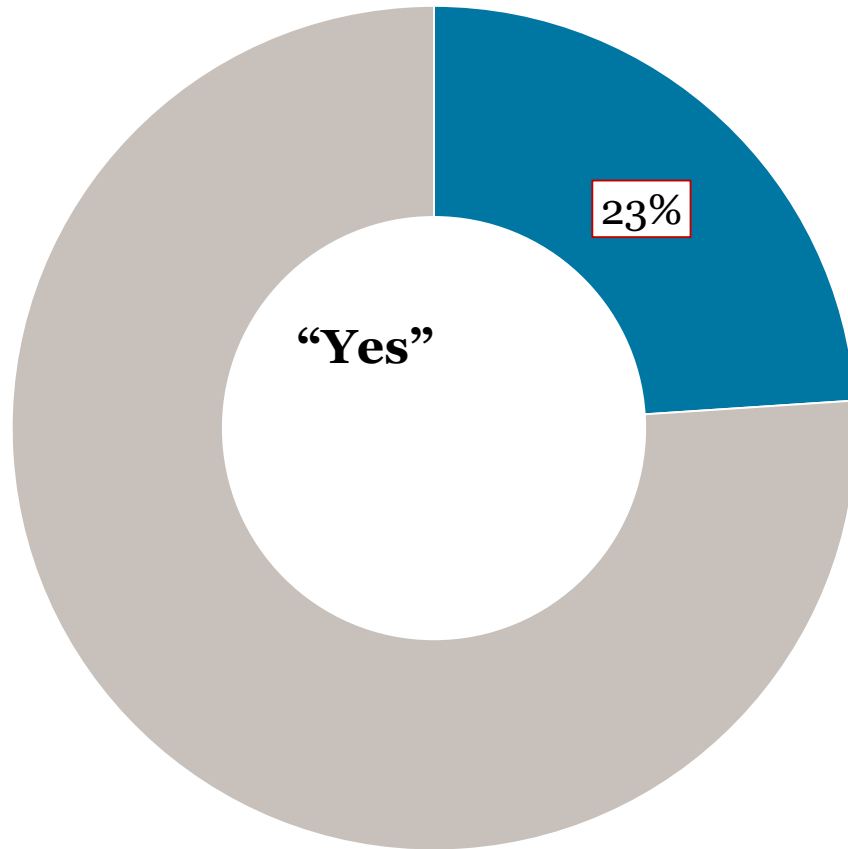

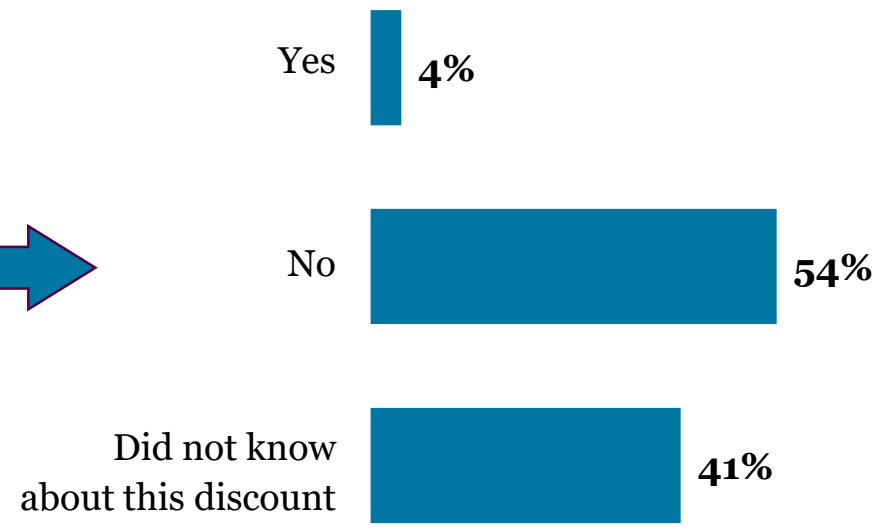
Q: Is there anything that would motivate you to engage in any of civil activities?



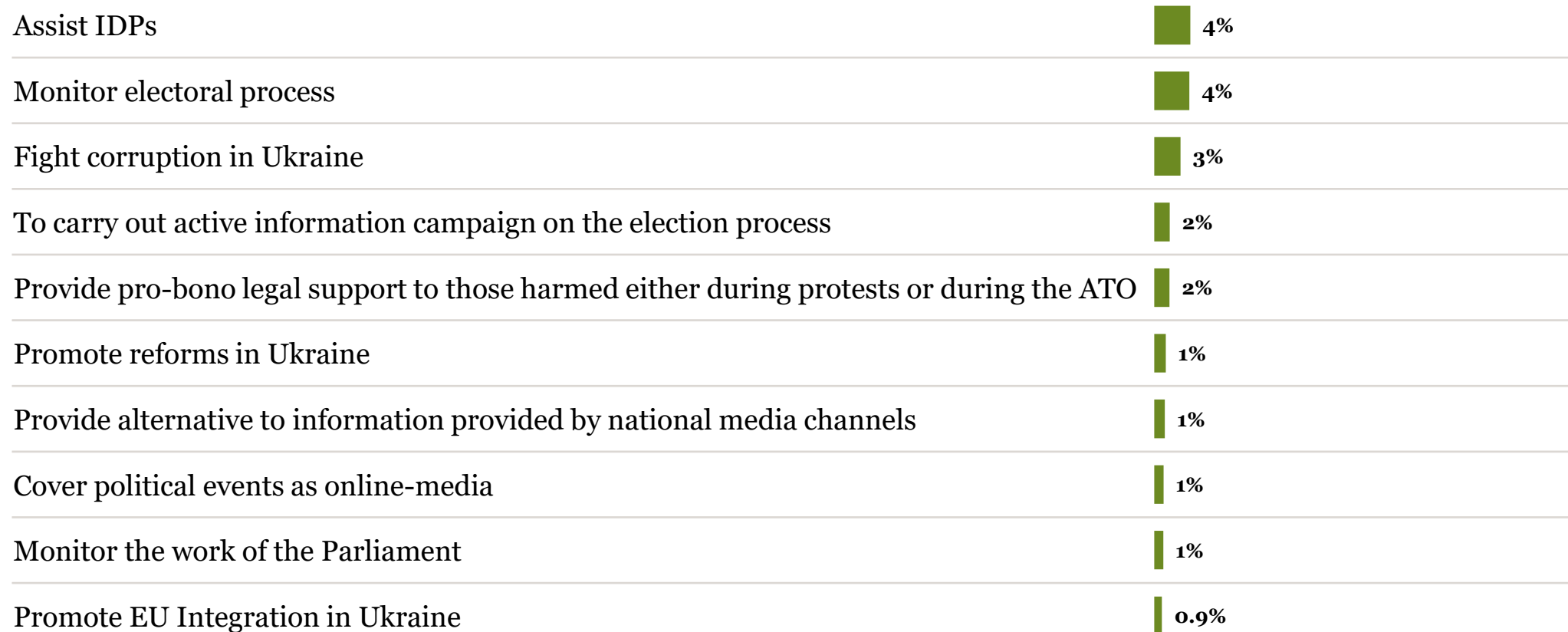

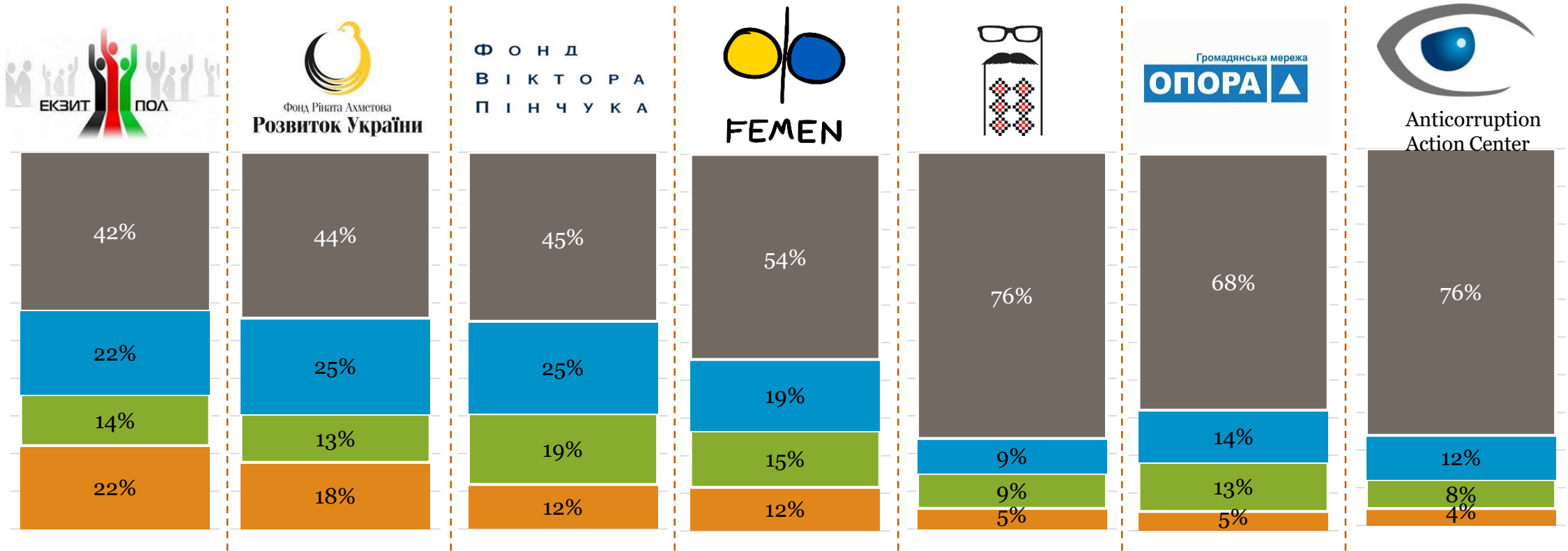

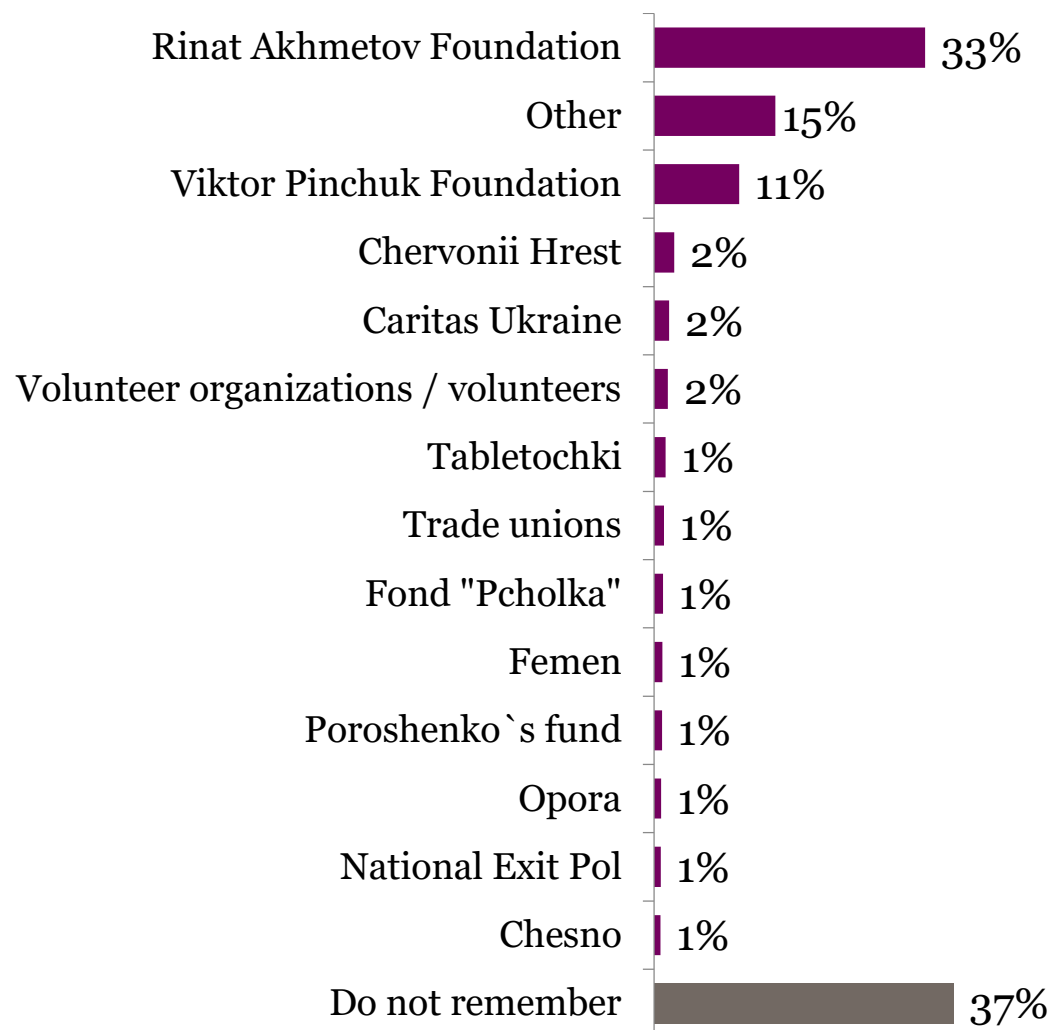

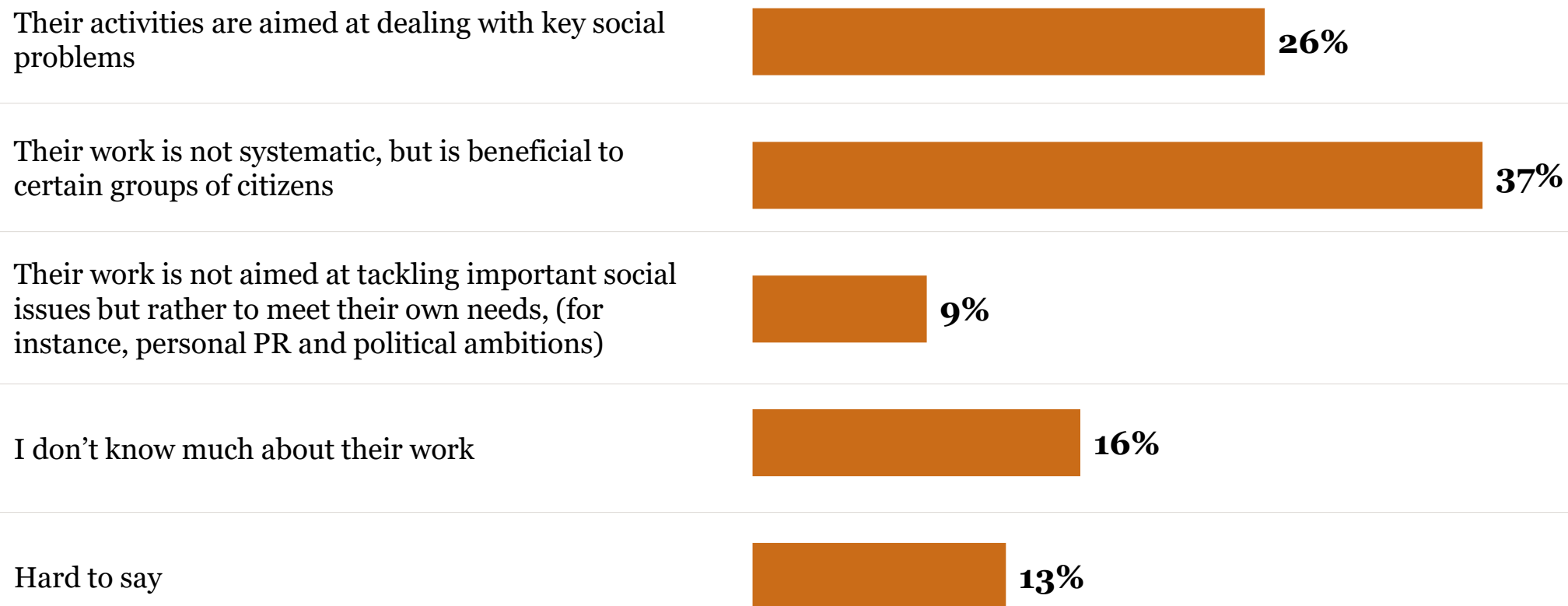

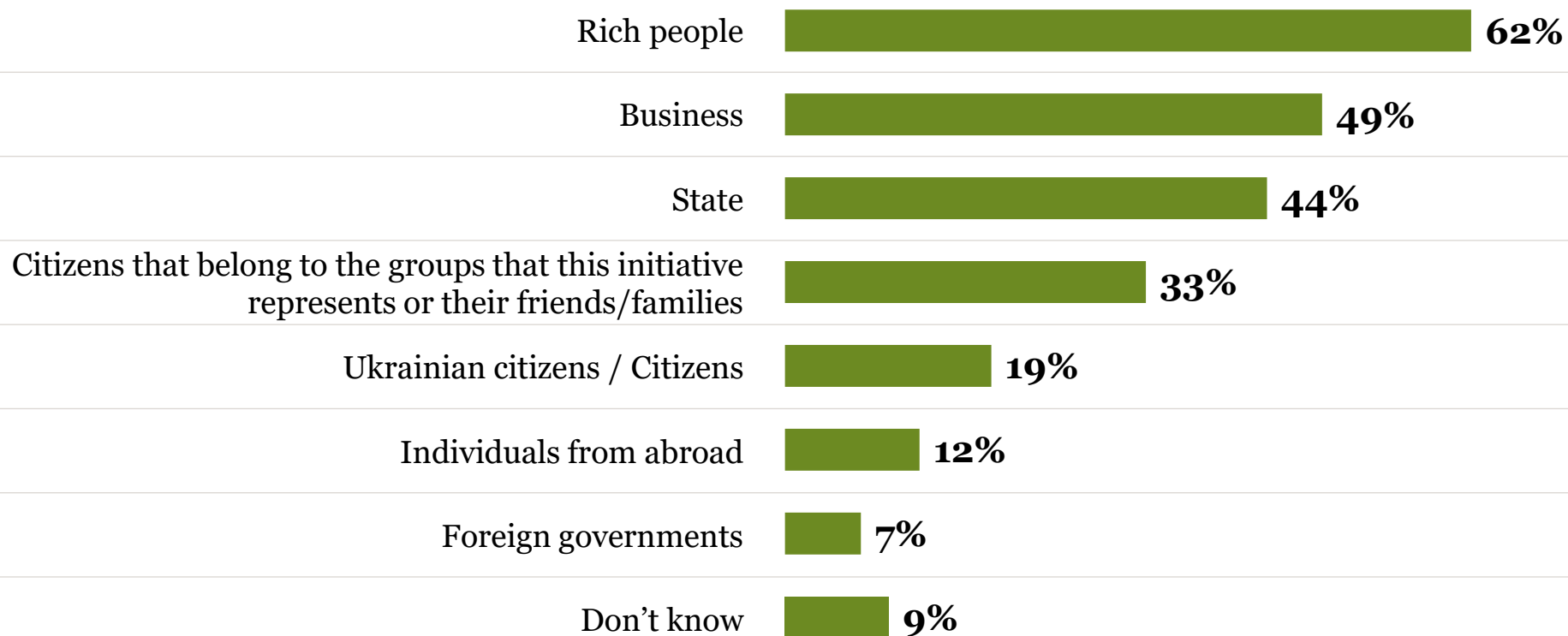

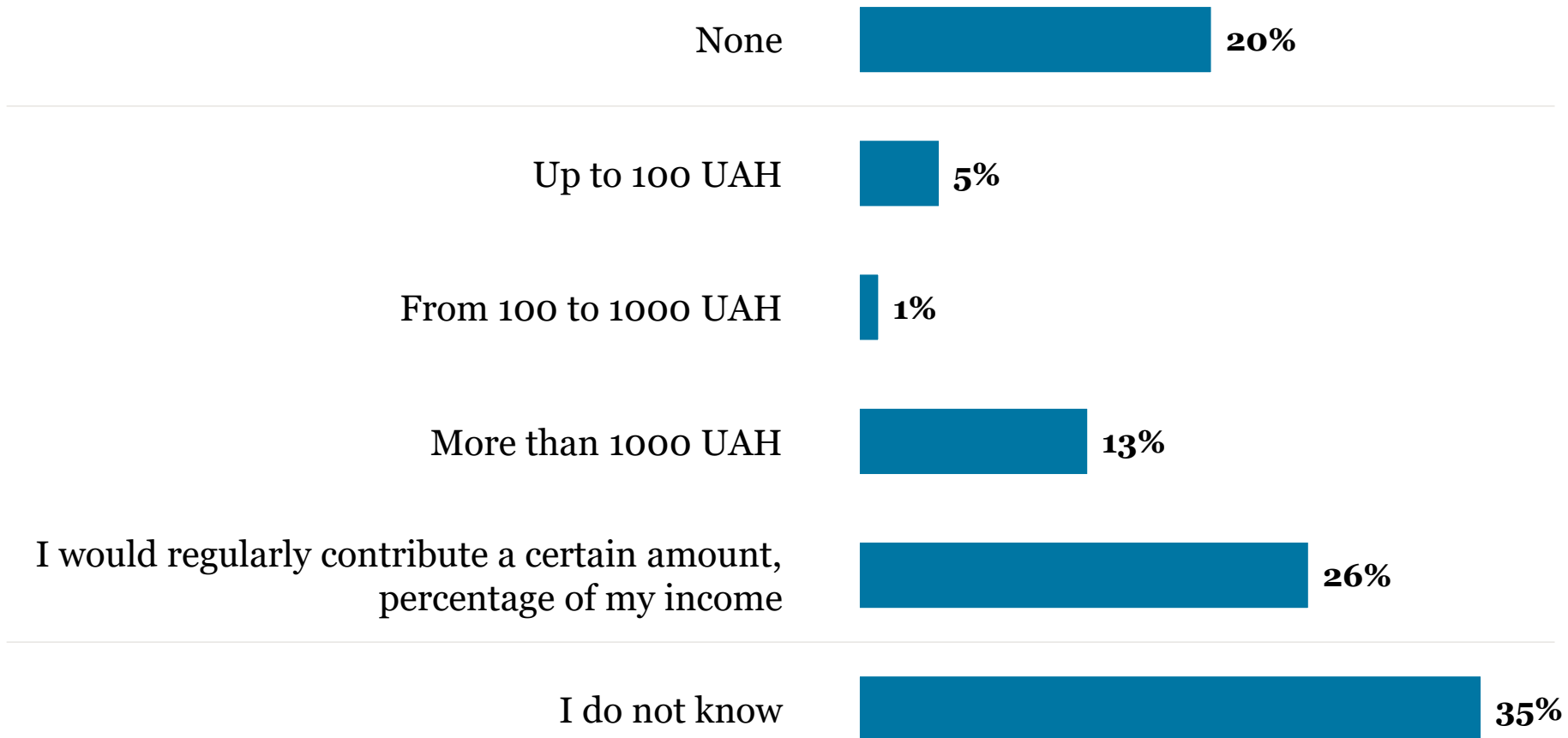

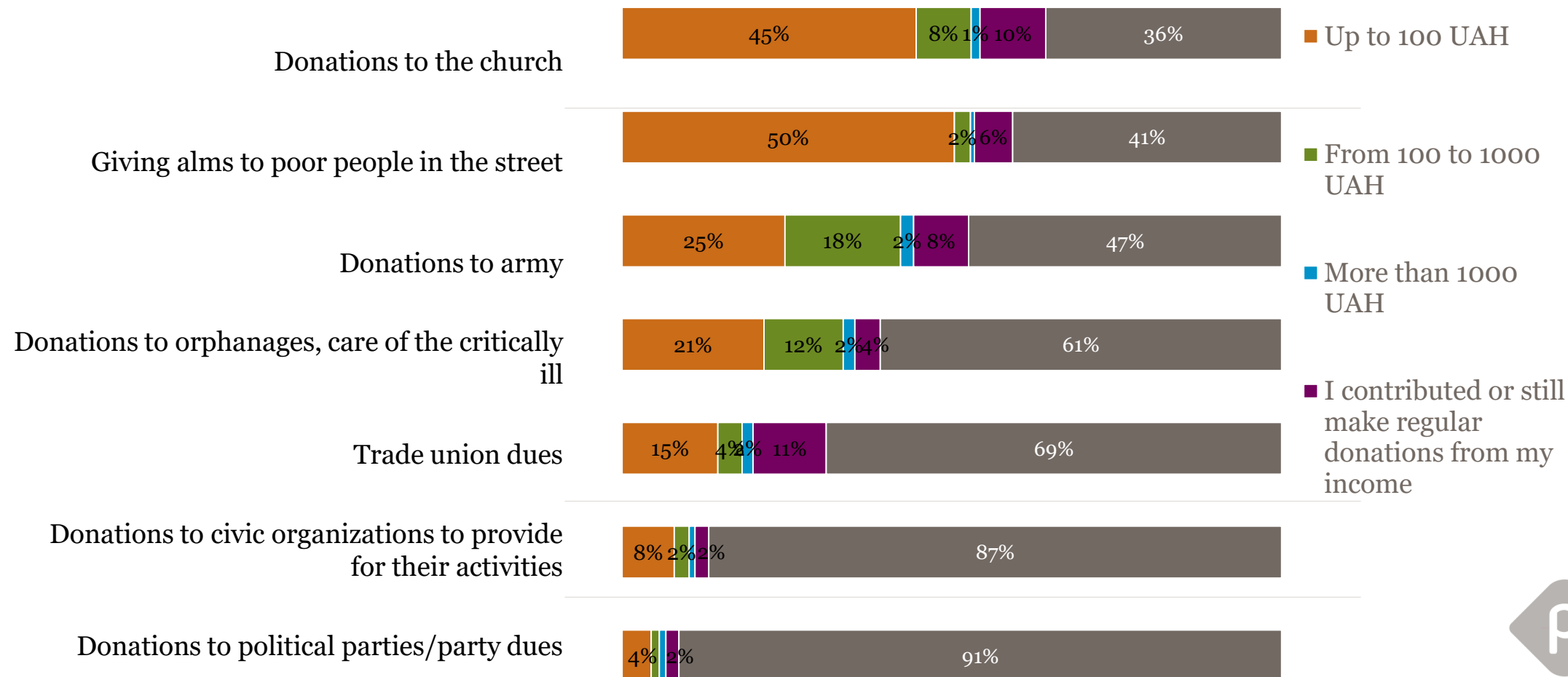

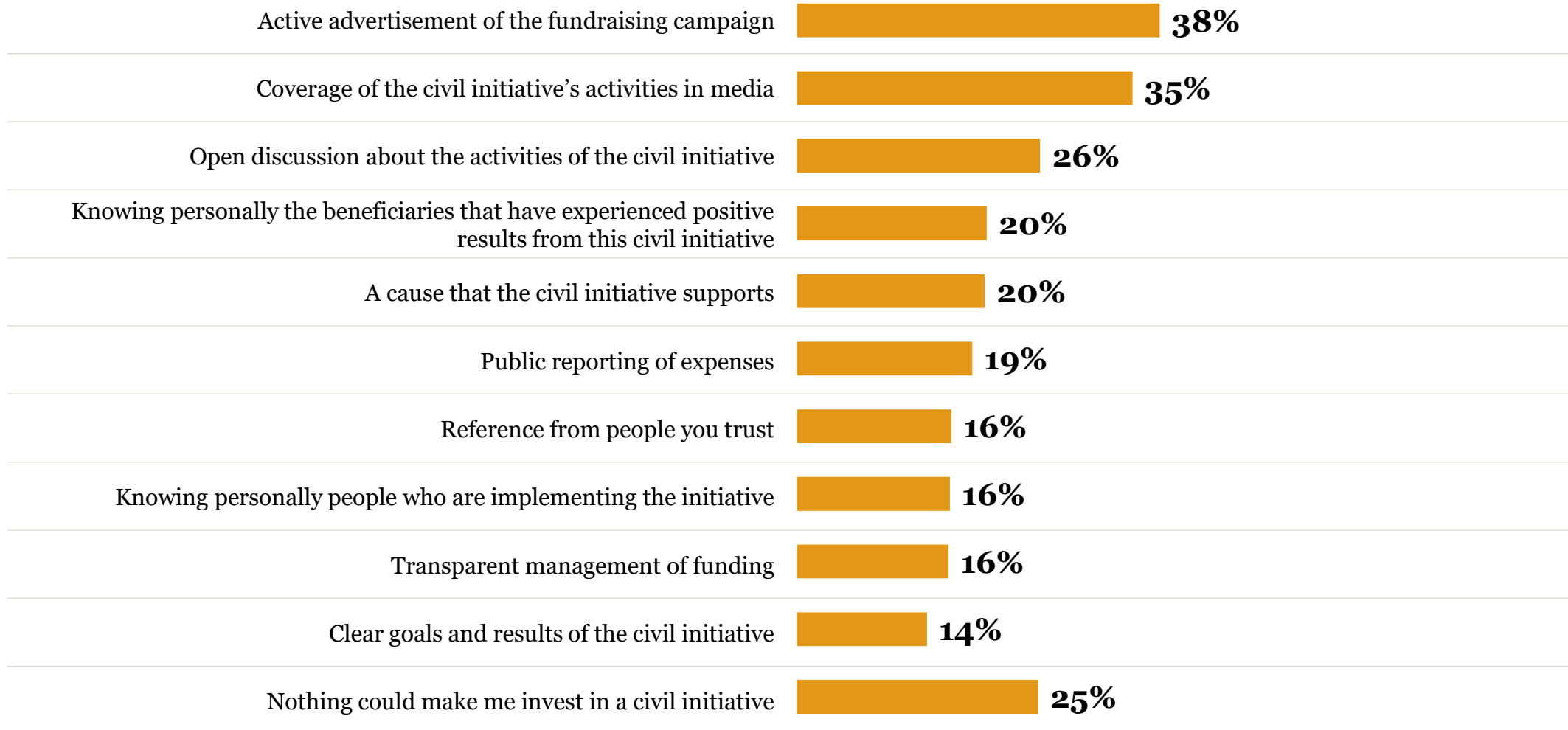
Q: If you choose to fund any initiative what would be the most convenient way for your contribution?



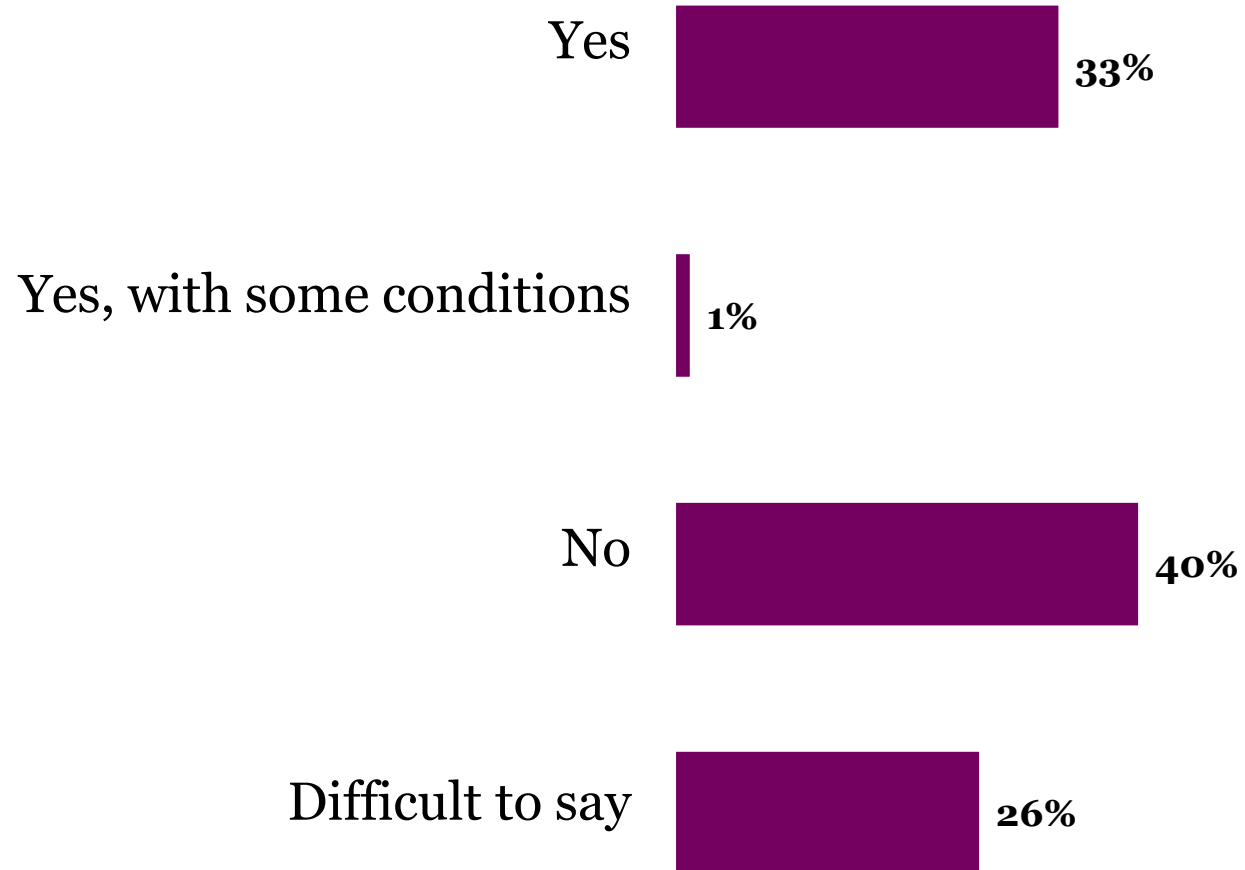
Q: If you decided to financially support a certain initiative, which factors would play the most important role in your decision? – multiply response set

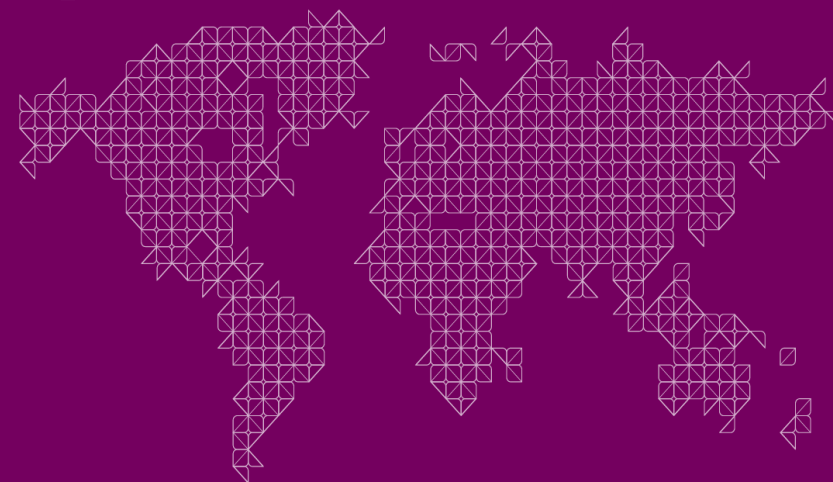

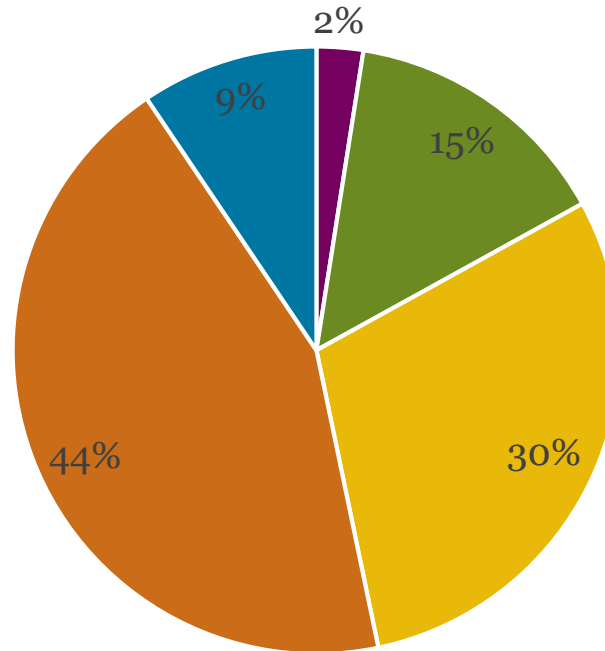

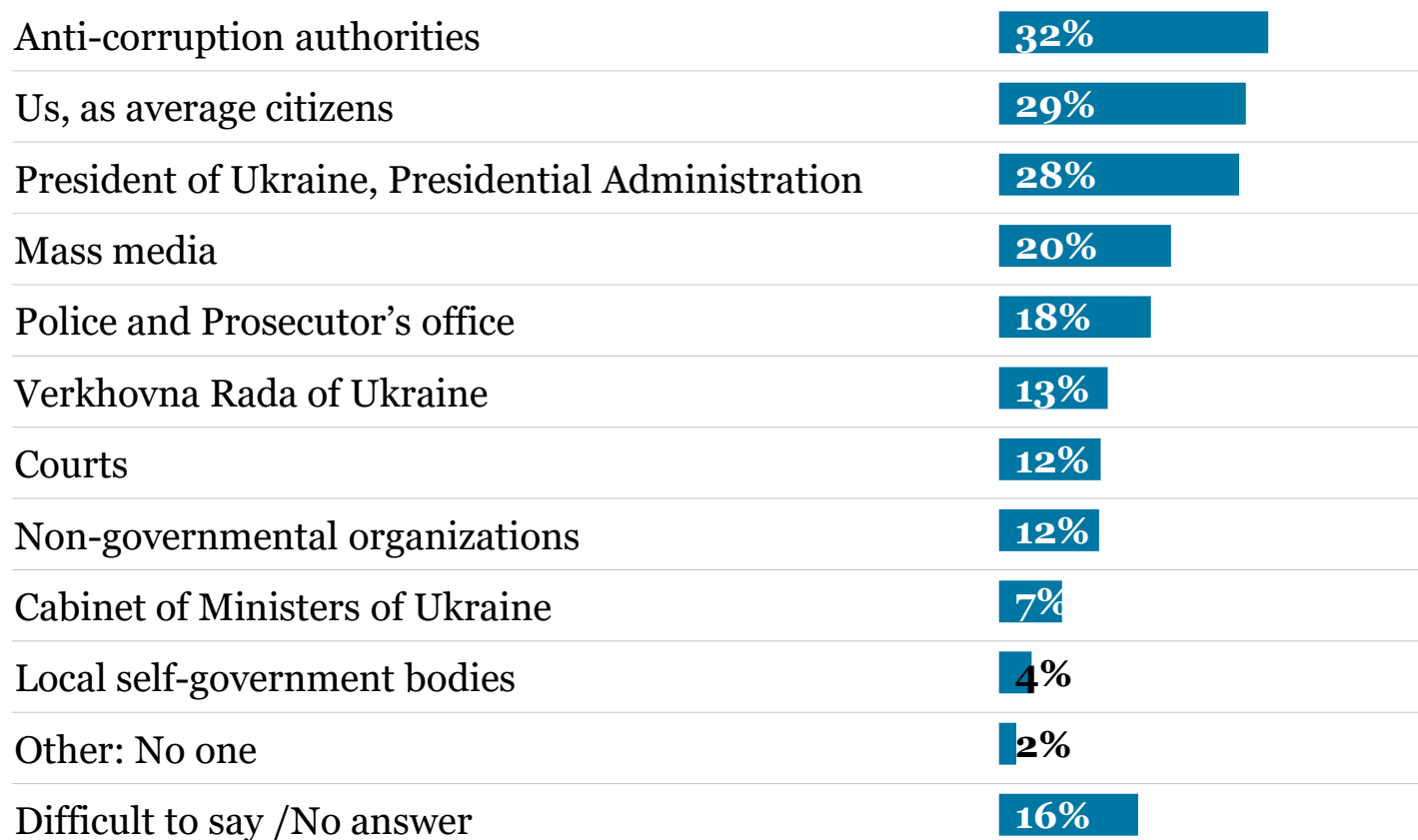

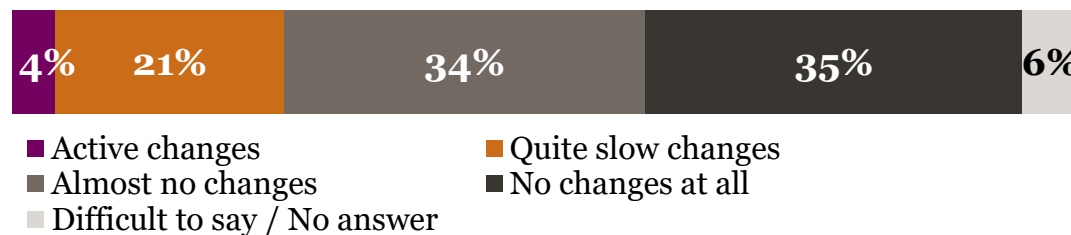

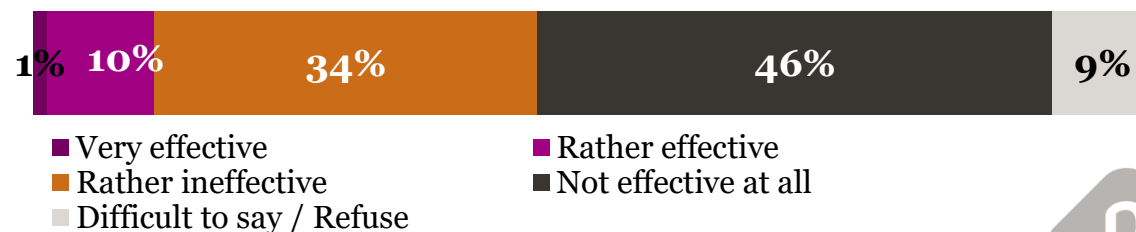

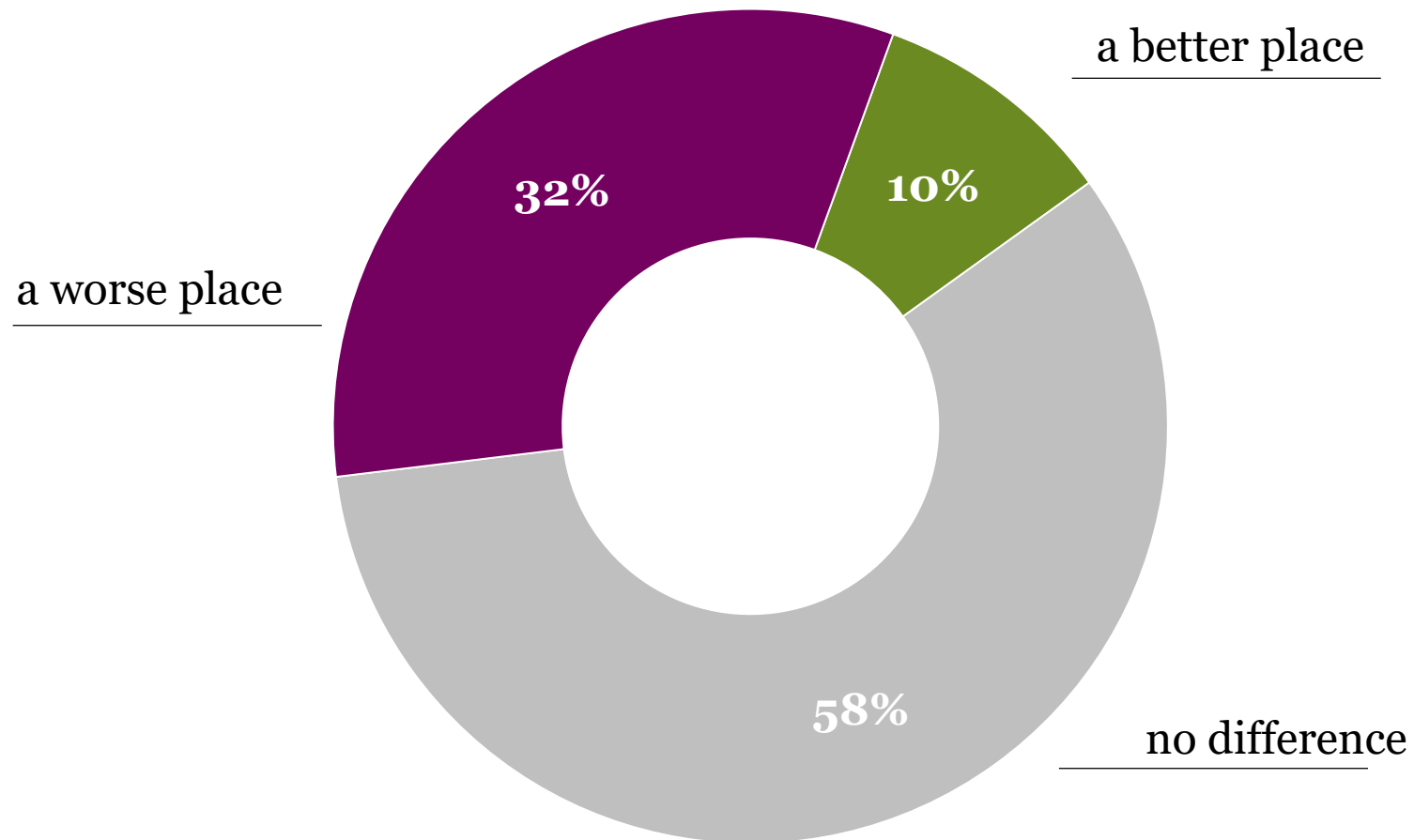

To be civically literate, a respondent should answer correctly to at least 10 out of 13 questions:

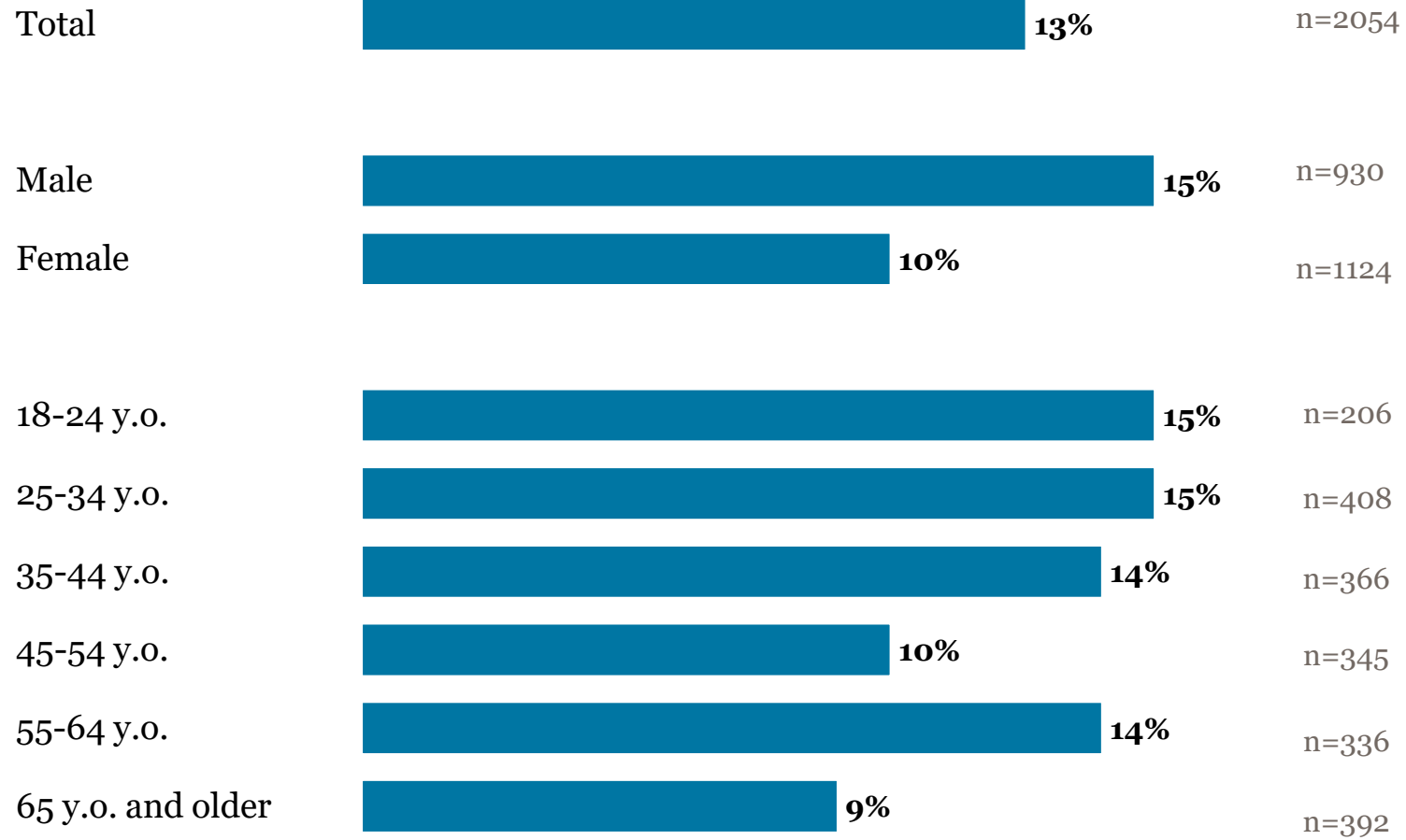

6. Who has the right to adopt laws in Ukraine? (*The Verkhovna Rada*)
7. How is local self-government formed? (*Elected by the electorate of certain territories*)

9. What is the rate of income tax applied for individuals in Ukraine, according to the legislation? (*18%*)
10. Which body approves the state budget of Ukraine? (*The Verkhovna Rada*)
11. Which body approves the local budget in your community? (*The local council*)
12. Is it necessary to have authorization from the local authorities to hold a peaceful assembly or a demonstration? (*No*)
13. On what grounds can the local administration prohibit holding a rally? (*If the rights of other people are at stake*)



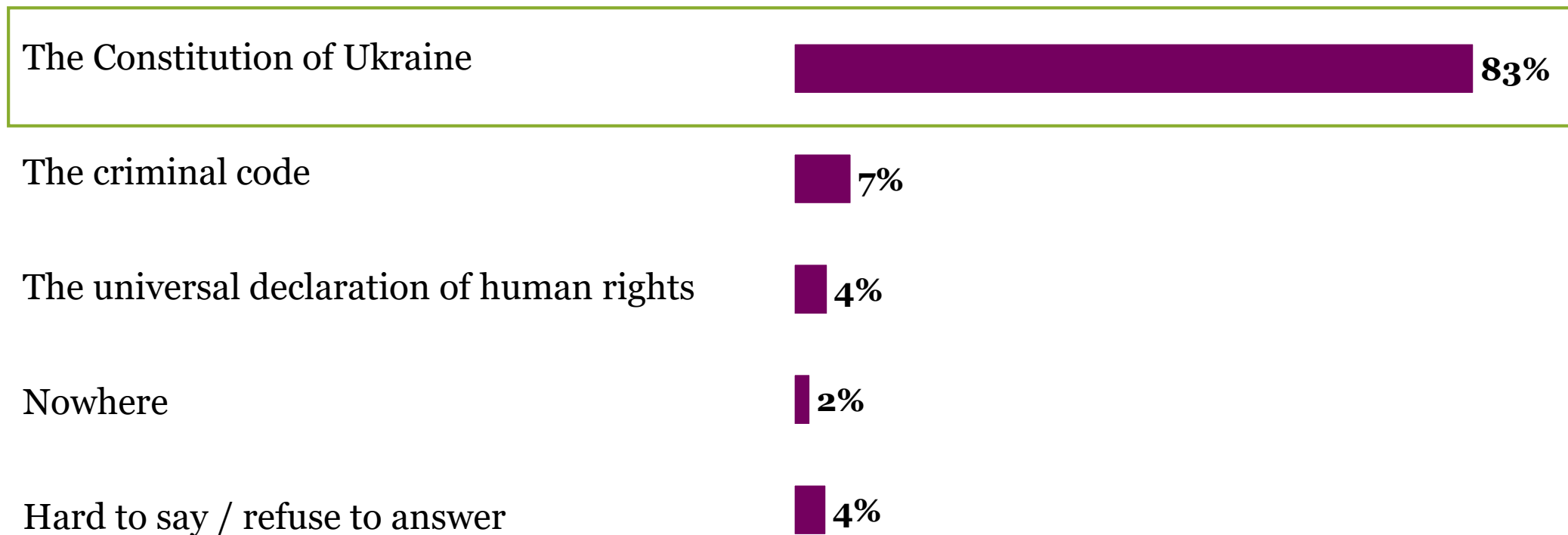
Civic literacy: by region



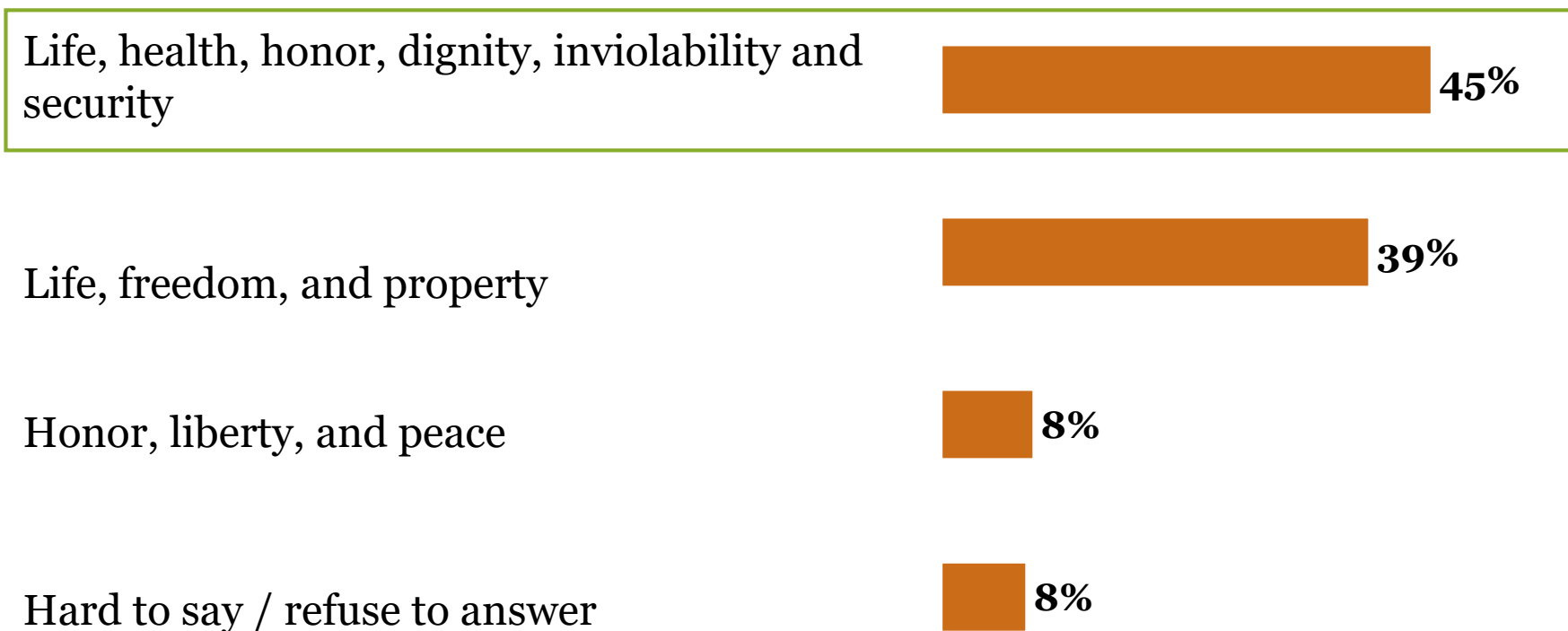
Civic literacy: by gender and age categories



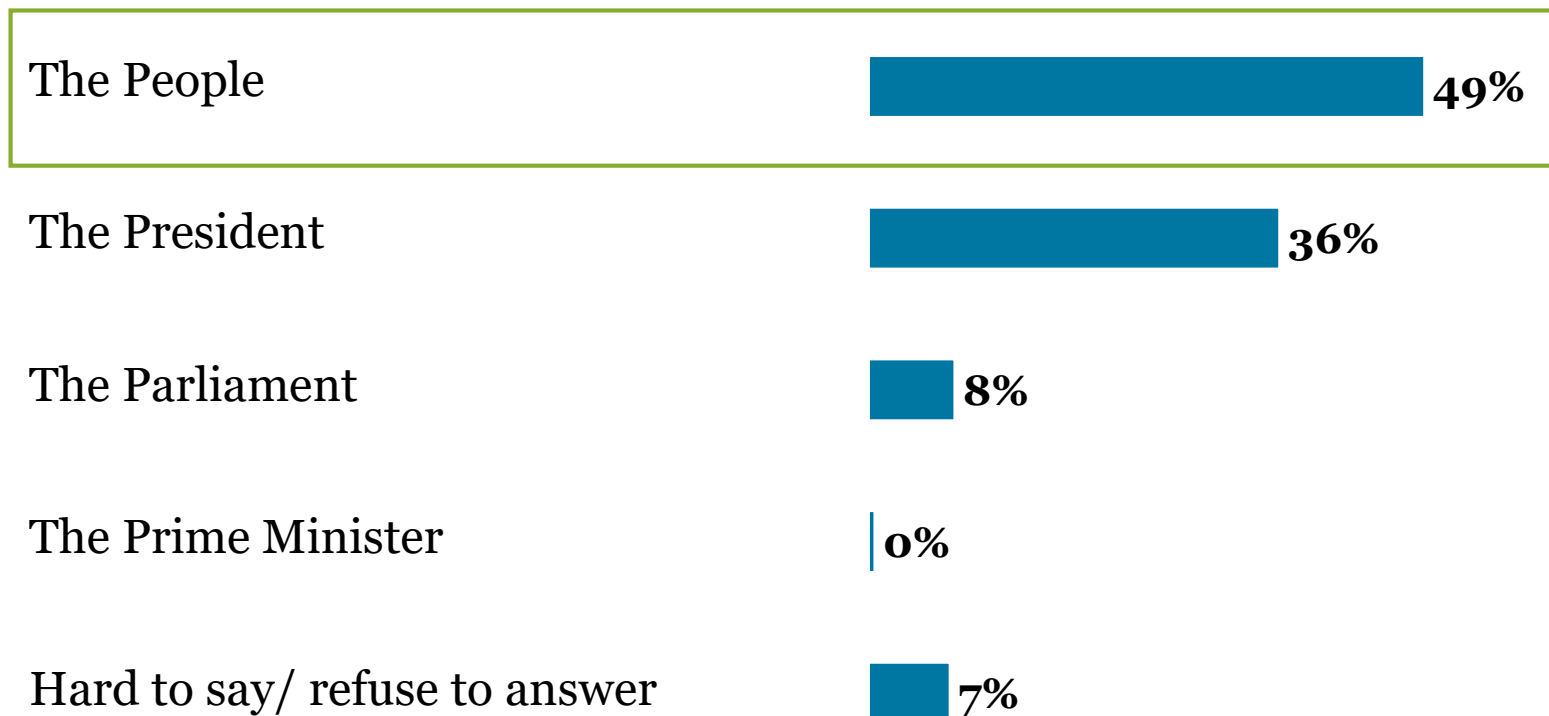

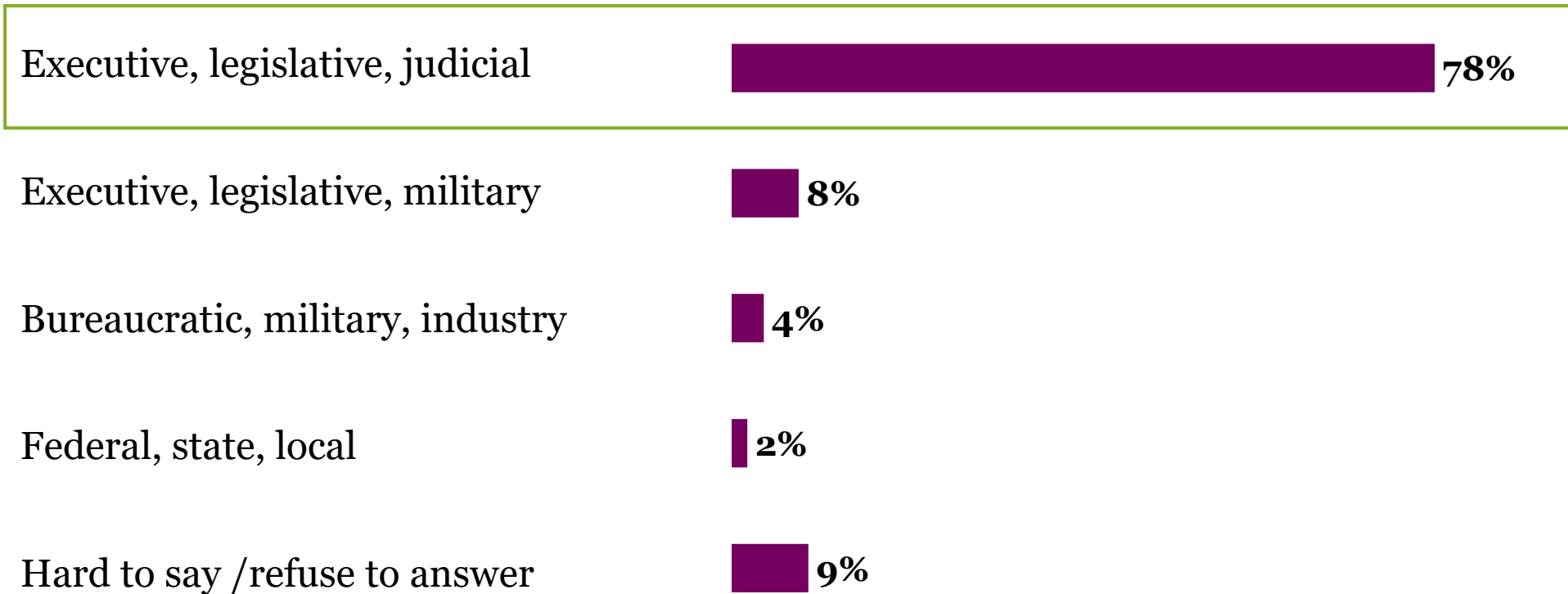

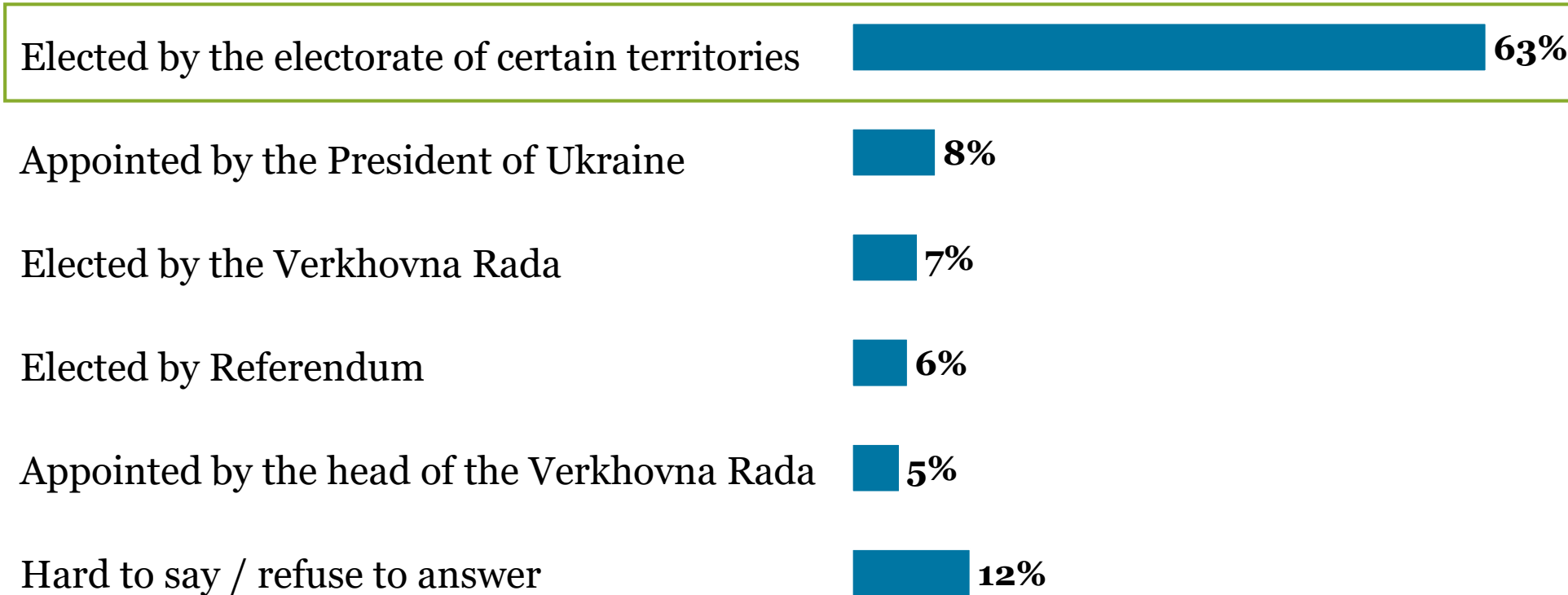
